

WO Maseru police constables have been arrested for illegally selling a gun to a man they did not even know.

In an interview, police spokesperson, Senior Superintendent Mpiti Mopeli, yesterday said a 4+1 taxi driver, who is a friend to the two officers, acted as the middle man in the illegal transaction. Shortly afterwards, the two corrupt officers went after the buyer, pretending they had received a tip that he was in possession of an illegal forearm. They then demanded an M2000 bribe to let the man go scot-free. Following an official complaint by the man, a trap was set leading to the arrest of the two officers, Senior Supt Mopeli said.

Three months ago, the operation paid off as the LDF recovered three rifles, 11 cartridges and seven rounds of ammunition from some unidentified residents of Matelile, Mafeteng.

But even as the nation was celebrating the recovery of the few weapons in Matelile, there was yet another shocker with Lesotho Police Staff Association (LEPOSA) subsequently reporting that another 180 guns had allegedly gone missing at Mohale's Hoek Police Station. Mohale's Hoek borders Mafeteng and just like the latter district, it has had its fair share of deadly Famo

gang wars which have claimed sevcrimes locally and in eral victims.

In an interview, LEPOSA spokesperson, Police Constable (PC) Motlatsi Mofokeng, said it only came to light that the weapons were missing when they were supposed to be handed over to the new officer in charge of the station by his predecessor on 27 April 2022. PC Mofokeng said the new officer in charge was one Senior Inspector Sututsa. He did not say who his predecessor

However, Senior Supt Mopeli said they had not received any reports of missing guns at Mohale's Hoek Police Station. He said PC Mofokeng's comments were misleading and could spread alarm and despondency. Nonetheless, the LEPOSA spokesperson insisted that the weapons had gone missing from the police station.

Commenting on the latest scandal involving the Qoaling officers, Senior Supt Mopeli said their conduct tainted the image of police force.

"Their conduct compromises police work and taints the image of the institution as well. It is obvious that some of these officers were already criminals when they were recruited but we never get to know of it at the time of vetting them. However, the fact that we have already arrested them goes to show just how committed we are to flushing rogue police officers out of our system.

"It is really sad that in as much as we try to do our best to combat crime, some officers are not coming to the party. Now that we are forced to arrest our own, this can create animosity and a toxic working environment within our ranks.

"We therefore appeal to our members to refrain from crime as this taints the image of the police service," Senior Supt Mopeli said.

Fired NSS officers lose reinstatement bid

HE High Court has thrown out 77 former National Security Service (NSS) officers' application for reinstatement.

The former officers' case against their January 2018 dismissal by the previous government was heard by Justice Keketso Moahloli in March 2021. His lengthy delay in delivering judgement prompted the 77 to petition the court a fortnight ago.

Justice Moahloli then promised that he would deliver judgement on 12 August 2022.

Handing down the verdict on Friday, Justice Moahloli told both the applicants' lawyer, Joalane Lemao, and the respondents' lawyer, Piti Lebakeng, that he would only read out the order and the rest of the judge-

ment would be availed this week.

"I have with me here a very bulky document and I will not read it all. I will only read the order and the rest of the judgment will be available from next week on Wednesday. In the premise, the application is dismissed," Justice Moahloli said.

The sacked officers were appointed by the Pakalitha Mosisili-led seven parties' coalition government in 2016. They were however, dismissed by the successor Thomas Thabaneled coalition in 2018 allegedly because they had been hired on political grounds.

They then approached the High Court to challenge their dismissal and won their case in May 2019.

Judge Semapo Peete ruled at the time that the Director-General of the NSS, Pheello Ralenkoane, had acted unlawfully by terminating their employment.

This after he had first referred the matter to the NSS Board of Inquiry citing that there were some confidential issues relating to the officers which could not be brought before the High Court.

However, Mr Ralenkoane appealed the judgement in the Court of Appeal and the case was heard in 2019.

After hearing the case, the apex court referred the matter back to the High Court and ordered it to be heard by a different judge.

The case was then heard by Justice Moahloli in March 2021 and he only delivered his verdict over the weekend. One of the fired officers who spoke on con-

dition of anonymity for fear of reprisals, said they were disappointed by the judgment. They would consult their lawyer before deciding on the next course of action, he said.

We are hurt and disappointed because we had hoped that the judgement would be in our favour. But it is not over yet. We will consult our lawyer on the way forward.

We also feel hard done by the judicial system. It took more than a year for the judgement to be delivered and when the judge finally delivered it, he only read out the order instead of the full judgement.

We are confused as to how he reached his decision," the officer said.

Covid-19: New mass vaccination campaign launched

HE Africa Centres for Disease Control and Prevention (Africa CDC) has partnered with MasterCard Foundation to launch a new mass vaccination campaign against Covid-19 in Lesotho.

Styled the Saving Lives and Livelihoods Initiative, the ambitious campaign is targeting to have vaccinated at least 270 000 people in 12 months. This means that a tenth of Lesotho's 2, 1 million population would have been vaccinated at the end of the campaign.

Launched in June 2021, the initiative is a US\$1, 5 billion partnership between Africa CDC and the MasterCard Foundation to procure Covid-19 vaccines for at least 65 million people across the African continent.

In a weekend statement announcing the launch of the Lesotho project, Africa CDC said US\$807 067 has been set aside for the implementation of the mass vaccination campaign in Lesotho.

Lesotho first launched a mass vaccination campaign against the pandemic back in March 2021. However, public appetite to get jabbed appears to have stalled in recent months following the improvement of the Covid-19 situation in the country. Early this year, the government even disbanded the National Covid-19 Secretariat (NACOSEC), saying it had successfully brought the pandemic under control.

In its statement, Africa CDC said the vaccination drive is coming at a time when the country "only has 55 percent of the adult population fully

On his part, the Coordinator of the Africa CDC Southern Africa Regional Coordinating Centre, Lul Pout Riek, said initiative will "include a strong focus on Risk Communication and Community Engagement (RCCE) to enable Lesotho citizens, particularly young people and rural populations, to understand the safety and benefits of vaccination".

"Africa CDC is very honoured to launch the country implementation of the Saving Lives and Livelihoods initiative in partnership with the MasterCard Foundation, to support the Government of Lesotho in vaccinating its population.

"Covid-19 vaccines remain a critical tool in reducing transmission and ultimately returning the economies of Africa to normal. We recognise that the only way to end the pandemic and safeguard lives and livelihoods on the continent is to immunise a critical mass of the African population rapidly," Dr Riek

110 more illegal miners nabbed in latest SA blitz

... as Welkom Court hands down 18 year sentence to Lesotho national

NOTHER 110 illegal miners have been nabbed by the South African Police Service (SAPS). This as the South African government intensifies its war to contain illegal mining activities and other crimes in the neighbouring country.

While it is not yet clear if there are any Basotho who have been arrested in the latest blitz, they have nonetheless been fingered alongside Mozambicans and Zimbabweans in the escalation of illegal mining, murders, rape and other violent crimes in Gauteng and other parts of South Africa in recent weeks.

The arrest of the 110 follow the arrest of 82 other foreigners a fortnight ago. Most media reports in South Africa say that the 82 are Lesotho nationals. Popularly known as Zama Zamas, the illegal miners have also been accused of murders and other violent crimes.

In an interview last week with the Sunday Express, Gauteng police spokesperson, Brigadier Brenda Muridili, said some of the illegal miners were allegedly clad in the traditional blankets associated with Basotho, hence the widespread suspicion that Lesotho nationals were among the perpetrators of the heinous

Brigadier Muridili however, said they would only be able to confirm their identities after engaging South Africa's Home Affairs

Yesterday, SAPS released a statement indicating that another 110 illegal miners were arrested from Monday to Friday in West

"Following the two day Izimbizo held in Krugersdorp and Kagiso in the West Rand last weekend, the ongoing district and provincial operations have been boosted by additional forces from the (SAPS) National Head Office to combat illicit mining in the area," SAPS said in its statement.

"The units that have been deployed include Tactical Response Teams (TRT), National Intervention Unit (NIU) and Special Task Force (STF), Public Order Police (POP), Mounted Unit, Visible Policing, K9 Unit, Economic Infrastructure Task Team and Directorate for Priority Crime Investigation specifically to focus on medium to high risk situations in the district while and POP and Crime Prevention units focus is to enhance visibility and prevention of crime in communities. The Department of Home Affairs officials on the other hand are assisting with arrested undocumented persons.

"While the SAPS continues to work on an integrated plan with all relevant stakeholders to tackle the levels of the illegal mining value chain, the deployed members have this week, 8 to 12 August 2022, managed to arrest 110 suspects for charges that include contravention of the Precious Metals Act, contravention of the Immigration Act, possession of unlicensed firearms and ammunition as well as possession of drugs.

"During the operations, the teams recovered a rifle that belongs to the estate of a deceased man from Mpumalanga, two unlicensed firearms, generators, loads of gold bearing material, explosives and drugs among other things."

The Gauteng Provincial Commissioner of Police, Lieutenant General Elias Mawela, commended the multi-disciplinary teams for their efforts in tackling illegal mining and other crimes in the West Rand.

In another development, a 30-year-old Mosotho man, Thabo Motinyane, was on Thursday sentenced to 18 imprisonment for attempted murder and armed robbery in South

In an interview, SAPS Welkom spokesperson, Captain Stephen Thakeng, said Motinyane was convicted on two counts of attempted murder, armed robbery, possession of an illegal firearm and being an illegal im-

Motinyane was arrested on 11 November 2021 and held in custody until the finalisation of his trial. He was last week sentenced by the Welkom Regional Court.

The Lesotho national, Thabo Motinyane (30), was sentenced to 18 years in jail for two counts of attempted murder, armed robbery, possession of illegal firearm and illegal immigration, on Thursday in Welkom Regional

"On 11 November 2021, members of Thabong SAPS in welkom responded to a complaint of a shooting incident at One Stop Car Wash in Constantia Road, Thabong. Upon arrival, SAPS members found that the business premises was already closed and according to witnesses, the victim who was shot, had been taken to Bongani Hospital in the area. Members rushed to the hospital and the victim was so serious and was admitted in the Intensive Care Unit (ICU). He was later transferred to Bloemfontein for further medical treatment.

"Preliminary investigations revealed that the victim was robbed when he was shot. After a thorough investigation, Motinvane was arrested in G-hostel and identified as a foreign national, who was positively linked with the armed robbery in Constantia Road. He was then charged and on Thursday sentenced to 18 years imprisonment for all the charges in Welkom Regional Court," Captain Thakeng said.

Three other Lesotho nationals are currently on trial in South Africa for murder and attempted murder charges. The three are Moeketsi Hlaudi, Keketso Ntsabisa and Thabiso Ramollo. They appeared at the Bonnievale Magistrates' Court, in Western Cape a fortnight ago.

According to a recent statement by South Africa's National Prosecuting Authority (NPA)'s Western Cape Regional communications manager, Eric Ntabazalila, said the three were extradited from Lesotho to face charges of murder, attempted murder, robbery with aggravating circumstances as well as the unlawful possession of firearms and ammunition.

"On 27 July 2022, three Lesotho nationals, Moeketsi Hlaudi, Keketso Ntsabisa and Thabiso Ramollo appeared at the Bonnievale Magistrates Court following their successful extradition from Lesotho to South Africa," Mr Ntabazalila said.

"The prosecutor, Advocate Megan Blows, told the court that in 2019, the accused killed Kapteinsdrift farm owner, Jurie Wessels, on his farm in Bonnievale. The accused, who performed seasonal work at the deceased's farm, made use of their knowledge of the farm and planned to attack the farm owner and his wife. They tortured Wessels and his wife by stabbing them beating them and throwing boiling water at them.

Mr Ntabazalila said a fourth suspect, Ntabanyane Tlali, was immediately arrested and he is appearing at the Western Cape High Court in connection with the crimes. Mr Ntabazalila said the other suspects fled to Lesotho and the NPA subsequently applied for their extradition to South Africa.

A cursory examination of Twitter, Facebook, other social media platforms as well as the mainstream media in South Africa will show that there is rising anti-foreigner and in particular anti-Lesotho sentiments due to the escalation of crimes allegedly being committed by Lesotho nationals in that country.

This according, to analysts and major political parties, could jeopardise Lesotho-South Africa relations which have been most cordial since the dawn of majority rule in 1994.

South Africa could impose stricter immigration controls as part of efforts to stem the rising tide of crimes committed in the neighbouring country by Lesotho nationals. Should this happen, ordinary, innocent Basotho will be the ones to suffer any punitive measures imposed by the neighbouring country, more so as they are dependent on South Africa for virtually everything from health services to

In a recent interview, National University of Lesotho (NUL) Faculty of Education lecturer, Mahao Mahao, said it was unfortunate that Basotho were suspected of involvement in violent crimes in South Africa.

'This brings reputational damage upon Basotho and Lesotho in general," Dr Mahao said.

"The bilateral relations between Lesotho and South Africa could be severely affected leading to stricter foreign policy adjustments. While Lesotho continues to fight for more freedom of movement for its citizens between the two countries, its people's alleged involvement in crime in South Africa could compromise or render such efforts abortive.

"Even worse, ordinary Basotho could be viewed with suspicion and be targets of violence as a form of revenge by South Africans,' Dr Mahao added.

He blamed the Lesotho government and its security agencies for "failing to deal decisively with violence perpetrated by the blanketed

"The much bigger picture in this whole issue is the failure of the Lesotho government and its security agents to deal decisively with violence perpetrated by blanketed men who have created violent gangs and continue to act with utmost impunity. "There are also men operating in abandoned South African

"This has created a dangerous mix of criminals who should be dealt with militarily since they openly carry high calibre weapons. What Lesotho has now effectively done is to export violence and infest another country with our own failures.

"Lesotho has itself has become a haven for criminals of all kinds. What we are witnessing in South Africa reflects Lesotho's failure to control its criminal gangs. If criminality alone was a measure of a failed state, Lesotho would certainly be labelled as such," Dr Mahao said.

The Lesotho Defence Force (LDF) has said it is engaging the South African authorities to allow them to swoop on some of the illegal mining centres to flush out Basotho who are not only responsible for crimes in South Africa but in Lesotho as well.

EU hosts International Youth Day

HE European Union (EU) in Lesotho celebrated International Youth Day over the weekend.

The day is observed annually on 12 August to raise awareness on the need to engage the youth in development. This year's theme is "Intergenerational solidarity: Creating a world for all ages."

To mark the day, the EU hosted a panel discussion in Maseru to discuss challenges faced by young people. Speaking at the event, Head of Cooperation of the European Union Delegation to Lesotho, Mario Giuseppe Varrenti, said youth voices need to be heard by authorities when decisions are made about

"When youth organise collectively, they can make their voices heard. This will give them a say on the future they want," said Mr

A public and motivational speaker, Lerato Mpaka, emphasised the importance of youth having skills to solve challenges affecting

"Youths need the right skills to resolve their challenges and to build the necessary grid and muscle to be productive. We are living in the 4th industrial revolution yet our institutions are not teaching their students to be

"When Covid-19 started schools closed forcing learners to study online. However, some didn't have the means to do so and this created a digital divide," Ms Mpaka said.

As at March last year, 4,5 million young people resigned from their jobs worldwide due to mental health challenges. Ms Mpaka said had these youth been equipped with skills to help them cope with their situations, they would have kept their jobs and contributed to development in their countries.

"Mentoring is necessary to shield youth from being part of the resigning gang.'

A human rights activist with non-governmental organisation, Democracy Works Foundation, Kahisano Kolobe, said the country's youth should play an active role in promoting democracy.

"Youths don't see the need to vote. This denies them a chance to vote for people who will lead them and to decide their future,"

Neo Kabi, a Lesbian, Gay, Bisexual, Transgender, Queer (LGBTQ+) community activist, said they want an inclusive Lesotho

where everybody's rights are considered. In a statement, UN Secretary-General António Guterres, said the objective of International Youth Day 2022 is to amplify the message that action is needed across all generations to achieve Sustainable Development Goals (SDGs) and leave no one behind. The day also seeks to raise awareness on certain barriers to intergenerational solidarity, notably ageism, which impacts young and old persons, while having detrimental effects on society as a whole.

"Solidarity across generations is key for sustainable development. As we navigate the third year of the Covid-19 pandemic, it is important to recognise and address these agerelated barriers to build back better in a manner that leverages all generations' strengths and knowledge,' he said.

The Global Report on Ageism launched by the United Nations in March 2021 says that despite lack of research, young people continue to report age-related barriers in various spheres of their lives such as employment, political participation, health and justice.

It also says intergenerational activities can lead to a greater sense of social connectedness and solidarity.

Police need to do more to tackle murders of women, GBV: Morai

Tokelo Khausela

SCALATING murders of women and other forms of gender-based violence (GBV) ■are a shameful stain on the country's image, Deputy Commissioner of Police (DCP). Mahlape Morai, has said.

DCP Morai- one of the few female highranking police officers- said there was no excuse for femicide and the police needed to up their game to tackle the murders and other serious crimes.

She made the remarks while addressing female police officers in Maseru who had marched in commemoration of the late Martha Rasekoai. Ms Rasekoai was employed at the Ministry of Development Planning Ministry. Her mangled body was found at a rivulet in Ha-Tsolo, Maseru last month. No one has been arrested to date in connection with her gruesome killing.

The march was also aimed at commemorating Women's Month and raising awareness about the need to eradicate GBV

The officers came together under the umbrella of the Lesotho Mounted Police Service (LMPS) Women's Network, and marched from the police headquarters to Lifefo Ground in Ha-Thetsane over the weekend.

Speaking at the event, DCP Morai said this Women's Month should be used to prioritise issues affecting women and children. She said there was need for the police to increase efforts to tackle escalating femicide and other violent crimes against women.

"The rising statistics of femicide are a shame of our time," DCP Morai said.

"As police officers, we need to pull up our socks. One life lost is one too many. Violence against women and children is unacceptable and inexcusable. It needs to end," DCP Morai

She added that police had declared femicide and other forms of GBV "a pandemic" that had to be robustly dealt with. The LMPS Women's Network was mandated to empower female officers to fight GBV and promote peace, she said.

"The LMPS Women's Network is mandated to empower police women officers to fight gender-based violence and promote peace," she said.

Senior Inspector Mojabeng Letsela, of the police's Child and Gender protection Unit (CGPU), said her unit offers counselling services to GBV victims. It also offers protection to children, men and the lesbian, gay, bisexual, transgender and queer (LGBTQ) community who have suffered GBV. "It is commonly known

that men abuse women, but men are also abused by women. We can't condone any kind of abuse. A recent study conducted by the LMPS indicated that 86 percent of women are abused and 41 percent of men are perpetrators. These are alarming statistics requiring urgent attention to prevent the crimes from escalating any further," Inspector Letsela said. Libakiso Matlho, the Executive Director of

Women and Law in Southern Africa (WLSA) Lesotho, said her organisation capacitated women and children with legal information to enable them to tackle GBV.

"The elections are fast approaching and I plead with members of parliament and pomurdered in various parts of the country.

These murders are merely the latest in the ever escalating incidents of killings and violent crimes that have tainted the country's image and could render it an unsafe destination for investors.

As if to illustrate the dark depths of their cruelty and depravity, the killers of the latest five women chose the eve of Women's Month to commit their dastardly crimes.

Women's Month was originally aimed at commemorating the spirited fight by South African women against repressive apartheid laws in the 1950s.

Now Women's Month commemorates women in general, including Basotho women's fight for emancipation from gender-based violence, rape, killings and other socio-cultural and eco-

nomic ills. But the killers cannot be bothered. The killings are escalating with each passing

All of this is happening because at the level of the households where values of respect and the sanctity of human life are supposed to be inculcated, the responsibility has been abandoned, analysts say.

REASON and murder accused former Deputy Prime Minister, Mothetjoa Metsing, says he is "a victim of Lesotho's toxic politics of hate".

However, he would not retaliate and engage in the same political culture of mudslinging his rivals as he was back in the country to play his part in fostering a new culture of "developmental politics", he said.

The opposition Lesotho Congress for Democracy (LCD) leader made the remarks while addressing scores of jubilant party supporters who had thronged the High Court on Wednesday to support him ahead of his court appearance.

Mr Metsing has been charged alongside Development Planning Minister Selibe Mochoboroane, former army commander, Tlali Kamoli, army officers Captain Litekanyo Nyakane, Lance Corporals Motloheloa Ntsane and Leutsoa Motsieloa.

The charges are in connection with the 30 August 2014 failed coup against former Prime Minister Thomas Thabane's first government.

Until Wednesday, Mr Metsing had been a fugitive from justice, having fled the country in December 2021 to avoid being tried for the alleged crimes. Chief Justice Sakoane Sakoane even issued a warrant for his arrest on 6 December 2021.

Mr Metsing had since 2018 engaged in various legal battles with DPP Motinyane over her decision to charge him for treason and murder. Mr Metsing had argued that the charges were trumped-up and politically motivated while DPP Motinyane argued that the Crown had a strong case against the politician. She had even called for Mr Metsing to be remanded in custody while awaiting trial.

But in a surprising turn of events on Wednesday, the lead prosecutor, Shaun Abrahams, told the court that the Crown had reached an agreement with Mr Metsing's lawyer, Motiea Teele, for the cancellation of the LCD leader's warrant of arrest and that he be granted bail.

Justice 'Maliepollo Makhetha is now the presiding judge in the treason and murder trial in the aftermath of the Court of Appeal's 14 May 2022 judgement ordering Justice Sakoane to recuse himself from the trial. She granted endorsed Mr Metsing's settlement with the prosecution and granted him M50 000 bail.

Shortly after the court ruling, Mr Metsing

headquarters. The visibly emotional former Lesotho when he was arrested in South Africa deputy prime minister then addressed his followers, saying he was grateful for their support as he continued to be persecuted.

"I'm a victim of Lesotho politics, I have been constantly hounded," Mr Metsing said without naming his alleged tormentors.

"I don't know whether this is a day to rejoice or to look back on the journey I've travelled thus far. Indeed Lesotho's politics have hounded me over the years."

He said several politicians hated him "with a passion". He also accused an unnamed jourand his LCD supporters drove to the party nalist of fervently seeking his extradition to

last month. He was arrested on the South African side of the Maseru Bridge border after he had gone to South African immigration officials to extend his stay in that country. He had fled to South Africa in December 2021 to avoid standing trial for treason and murder alongside Mr Mochoboroane and others.

Although he had the treason and murder charges hanging over his head, he was arrested on the basis of the previous Thomas Thabane administration's 2018 application for his extradition to stand trial for corruption, fraud and tax evasion. Those charges arose from his alleged role in facilitating an allegedly corrupt tender for roads construction in Maseru and the alleged kickbacks he got from the contractor. He was subsequently freed on bail after the Lesotho government informed its South African government that it had no objection to his release.

In his Wednesday address to the party faithful, Mr Metsing said despite his alleged persecution, he had always done his best to avoid the politics of hate and name calling because these did not help the country in any way.

"You can vouch that you've never heard me insult or demean other leaders like they always do to me. Hate and name-calling don't develop a country. That isn't developmental politics. Yet some say if they want to make it in politics, they must just attack Metsing.

However, I'm back. Just like baby Jesus, I've been favoured by the Lord. I believe that we'll have a fruitful election campaign. I'm grateful to you all for being there in my hour of need. You're a blessing to me," Mr Metsing

His deputy, Tšeliso Mokhosi, concurred, saying Mr Metsing had been "a sacrificial lamb over the years being persecuted and blamed for everything that has gone wrong

"Sadly, even people with the dirtiest of hands have blamed him for things he never did. Ntate Metsing has walked a very hard journey. He is only returning to the country and he will only be starting to campaign when others have been doing so for a long time now. All we can do is leave everything in God's hands," Mr Mokhosi said.

Also present to welcome Mr Metsing were opposition Alliance of Democrats spokesperson, Thuso Litjobo, and HOPE spokesperson, David Seutloali.

"We're happy that you are back alive. We wonder why you have always been singled out. We welcome you home," Mr Seutloali

I make unilateral decisions because I finance SR alone: Mojapela

OCIALIST Revolutionaries (SR) leader, Teboho Mojapela, says he has the right to make unilateral decisions because he is the only one financing the party.

In a weekend interview with the Sunday Express at his mansion in Ladybrand, South Africa, Advocate Mojapela hit back at his detractors who have accused him of making decisions without consulting them.

ple holding different positions were not elected. They were all handpicked to take the party forward. Why must it be different when it comes to 'Mamarame?"

He said he was aware of opportunists in the party.

"I know them very well. Some are even close to me. They were going all over flexing their muscles, claiming that there were decisions that I couldn't make. I went ahead and made them anyway.

"I have said that SR will usher Lesotho to the biblical Canaan. I am a result-driven individual, and my motto is that 'I will get it come push

Adv Mojapela said if he saw po October 2017 and therefore had the tential in a person to make things happen, he would work with them irrespective of what his detractors say or think. He said it was funny that some of those people complaining about his appointment of Adv Matela were using his cars.

"I am not a boy. For as long as I live, SR will succeed. I will continue making unilateral decisions. You know why? Because even monied candidates who will be contesting elections under the SR banner still look up to me to finance their campaigns. They want me to provide Tshirts. I support this party generously from my pocket. I will therefore, make decisions if need be."

Adv Mojapela said he has no re-

According to him, forming SR was a calling from God that he was bound to fulfill.

He warned his political opponents not to drop the ball because I am coming for them".

"Basotho should expect anything. These criminals calling themselves politicians are out there doing everything to win the elections. But I have warned them that they had better not drop the ball because if they do, I'm coming for them full force. I want to lock up criminals who have plunged this country to its lowest low through stealing.

Adv Mojapela said he would no be worried if he fails to win the elections because he is capable of fending for himself.

He was not desperate whether people vote for him or not.

"It won't make a difference because God loves me. Whatever I ask of Him, He always provides. God never ceases to amaze me.'

Adv Mojapela said that producing a manifesto was not a priority for SR. But going into the elections, his party's message centred around uprooting corruption, upholding the rule of law and holding to account perpetrators of corruption.

last month on charges of trafficking Lerato Kaizer (29) and Mohau Majara (25) from Maseru to Dubai where they were allegedly exploited for their labour and underpaid.

He said to have trafficked Majara in October 2021 and Kaizer in March this year. He was also charged with illegally staying in Lesotho without a valid residence permit.

Rasheed has pleaded not guilty to the human tracking charges but entered a guilty plea to the charge of illegally residing in the country. Both Kaizer and Majara have already testified in court about how their trips to Dubai came about. Kaizer said he used to work at a barber shop with the accused. He said Rasheed informed him that he had some contacts in Dubai who wanted someone who can help them in various trading activities while Majara was promised football trials on the other hand.

During his cross examination last month by the Crown Counsel Steve Thaba, Rasheed denied all the accusations, saying he knew nothing about the work the victims had been recruited for in Dubai. He said his friend, one Amos in South Africa, was the one who spoke directly to the victims and organised everything pertaining to their stay in Dubai.

However, Magistrate Nthunya strongly rebuked him, saying he should not lie but tes-

'I must be frank with you and tell you that I don't believe some of the things you are say-

ing," Magistrate Nthunya said. "You are leaving your lawyer (Lehlohonolo Moseli) with lots of work because there are many lose ends that he will have to attend to. Remember that you are giving your evidence under oath and you strike me as someone who fears God. So, do not lie to me," Magistrate Nthunya added.

Human trafficking issues have taken centre stage in Lesotho, amid pressure by the US government to punish offenders.

Last month, the United States (US) government upgraded Lesotho to Tier 2 on its human trafficking index report for 2022.

This in recognition of "significant efforts" by the government to combat trafficking in the past year. Nonetheless, the US said Lesotho still had not done enough to address long-standing human trafficking concerns.

It said although Lesotho had made progress towards tackling trafficking in the past year, it still failed to meet "minimum standards in several key areas". Some of the outstanding areas include the failure to prosecute government officials implicated in the trafficking of victims, the US said. In instances where prosecutions had begun, Lesotho had however, failed to conclude the trials, the US added.

Although much more needs to be done, the upgrade to Tier 2 is nevertheless a welcome development. Previously the country had been on Tier 2 Watch List and before that it had been on Tier 3- the lowest ranking. Ordinarily countries in Tier 3 automatically lose US developments assistance and cannot benefit from multi-million-dollar programmes like the Millennium Challenge Corporation (MCC). Those on the Tier 2 Watchlist are still required to increase their efforts to deal with human trafficking for them to be eligible for various forms of US development assistance. Even though Lesotho was reselected for Second Compact under the MCC in 2017, a definite agreement on the size of the compact and funding had remained elusive until March this year when the US had satisfied itself that there had been progress that could lead to an upgrade to Tier 2.

Tenders: Govt must clean up its act

IHE government really needs to clean up its act when it comes to the awarding of tenders. It is not right that every tender award is followed by lawsuits and complaints about corruption and impropriety on the part of government officials and the winning bidder. A transparent process from the start to the end would surely help end such concerns about malfeasance.

As the Lesotho Times reports in its latest edition, the commercial division of the High Court has ordered the Ministry of Transport to disclose the record of all the proceedings which led to the awarding of the M33 million tender for the upgrading of Moshoeshoe I International Airport to a liquidated South African company, LTE Consulting. Judge Moroke Mokhesi made the order during the weekend hearing of an application by an association of local construction and mining companies for the nullification of the tender award to LTE. Justice Mokhesi ordered that the records be availed within seven days of receipt of his 5 August 2022 ruling.

Calling itself the Civil Mining and Building Constructors, the association was last Wednesday joined in the application by a local consultancy, PM Aviation Consultancy. PM Aviation was one of the four companies which lost the airport tender to LTE Consulting in June 2021. Transport Minister Tšoeu Mokeretla, LTE Consulting and Attorney General Rapelang Motsieloa are the first to third respondents respectively in the application.

Even as we await for whatever will be revealed when the transport ministry's records are disclosed as directed by the High Court, some are already speculating that the disclosures will reveal impropriety on the part of the government.

This is because LTE Consulting is owned by controversial South African businessman, Thulani Majola, who is said to enjoy cordial relations with politicians in both the Lesotho and South African governments.

Besides that, the tender was awarded to LTE when the Johannesburg High Court had granted an order for its liquidation over

South Africa's famed AmaBhungane Centre for Investigative Journalism published a story about Mr Majola's alleged use of his political connections in Lesotho to land the multi-million maloti tender. The article also stated that the airport tender was awarded to LTE four months after its liquidation.

The liquidation, the article stated, was as a result of LTE being accused of failing to honour a M23 million debt to its South African sub-contractor, Kontinental Engineering Consulting, for a bus station construction project for the City of Ekurhuleni in 2020. LTE had initially entered into talks regarding a settlement with Kontinental after the latter had filed a liquidation application in the Johannesburg High Court.

However, the parties failed to reach an agreement and Kontinental went back to court, arguing that LTE had paid M14 million but still owed M8, 9 million. This led to the eventual liquidation of LTE, according to AmaBhungane. A final liquidation order was

then issued on 24 February 2022.

This has prompted the Civil Mining and Building Constructors/ PM Aviation application challenging the tender award to LTE Consulting.This is just the latest in the ever-growing list of government tenders that have been challenged in the courts by disgruntled losing bidders. Oftentimes the implementation of much-needed projects is stalled by such lawsuits.

But all of this can be avoided if only government was transparent in its business. There must be transparency and accountability at every step of the process until a tender is awarded. After all, public funds are involved and the public has a right to know what is being done by their representatives with their (public's)

We have also noted with concern that many of the contractors are doing shoddy jobs. No action has ever been taken against such contractors. One only has to look at the state of our roads in Maseru, some which were refurbished less than two years ago, to understand what we are talking about.

The roads are now filled with massive potholes. Interestingly enough, the prime minister and his government officials travel on these roads on a daily basis. We wonder whether they are well cushioned by their top of the range 4 ×4 vehicles to the extent of not seeing or even feeling the dangers posed by such roads to motorists. We have never been called to a press conference or seen any state document containing names of companies that have been blacklisted by the government for poor workmanship. We cannot go on like this. Something has to give. Contractors should be held to account for their work.

The phobia for xenophobia: Thinking through the Krugersdorp incident

N May 11, 2008, there was an eruption of violent clashes between black South Africans and those from other African countries in the densely populated Alexandra township of Johannesburg. During these bloody clashes, it emerged that the motive of the violence was a phenomenon called xenophobia.

Since then, confrontations that transpired between black African people in South Africa have been wrapped under the same blanket of xenopho-

Old images and videos of people being attacked and scorched by fire are deliberately dispersed in the media and other social media platforms in the interest of fuelling and spreading this narrative across the African continent and the world.

Following the recent incident in Krugersdorp, west of Johannesburg, where a group of illegal immigrants is alleged to have sexually abused eight women, the conversation about xenophobia has again come to the fore.

This time, it is in respect of a violent attack on people who are perceived as illegal miners by angry community members in the same area where the rape incident took place.

In light of this, the article seeks to interrogate the meaning of xenophobia, and the basis on which it is alleged to find expression in the black communities of South Africa.

According to the definition, xenophobia means hatred for what is foreign (in this case foreigners). It is a dislike for people from countries outside your own.

However, there are noticeable limitations to this definition of xenophobia in explaining the complex questions of identity in South African

For instance, there is no factual basis to the claim that South Africans despise people from other African countries. Black South Africans mingle freely with other Africans on university campuses, schools, and in the workplace.

And in these sectors, no incidents of violent clashes have ever taken place or been reported. Why, then, if South Africans are inherently xenophobic does this not take place?

The truth is that part of the continent's post-colonial reality is a leadership failure, lack of opportunity, and political instability. Thus, many Africans descend on countries like SA in search of better

opportunities for their lives. Ūpon arrival, they find a local crisis whereby locals are without jobs or

any economic activity as a legacy of apartheid and colonialism.

And the ripple effect is that by virtue of their desperation, they are forced to compete for these limited resources for their survival.

That is to say, the battles only find expression at grassroots level because people scramble with each other for jobs and limited economic opportuni-

Consider the scenario: you have one piece of meat in hand, but are surrounded by four starving pit bulls. If you threw the piece of meat in the air the four pit bulls would battle and eat each other in a quest to acquire the piece of meat for themselves.

Essentially, the battle for limited resources is a colonial construct in South Africa whereby the black majority is forced to battle for the crumbs that fall from the white table.

Additionally, in the context of South Africa, the conflict has primarily been between locals and those they perceive to be in the country illegally. In other words, it is not all foreigners who become the target of the attacks or bad treatment.

Interestingly, some political leaders like the president of the EFF, Julius Malema, have argued that borders are "colonial" and "artificial" and ought not to be obeyed. He has said there are no borders in Africa.

He is right in his historical account of the borders, however, in our ideological appreciation of black relations

in Africa, there is also a fundamental commitment to the rule of law that was made by the forebears of our constitutional democracy.

Do we then abandon the laws of the country in pursuit of this ideological path? Why do we not adopt the same approach as far as other laws are concerned? Who decides for us what laws to obey and what laws to undermine?

The principle is simple, those who come into the country must do so within the legal frameworks of the country.

Those who have gained entrance, must not involve themselves in illegal activities like cash-in-transit heists, the drug trade, and even the rape of

"Pan-Africanism is not merely a unity of colour but a unity of common condition," said Walter Rodney.

To support Rodney's view, Ngugi Wa Thiongo argues that Pan-Africanism is congruent with the African humanist those at whose heart is universal citizenship, unity, love, harmony, sharing, and co-operation.

Therefore, our brand of Pan-Africanism cannot be based on illegality because then, we give credence to the false notion that we are a barbaric and disorderly people.

We ought to be united by a common condition as Africans. And we ought to be the first ones to reprimand any bad conduct by any one of us.

A good relationship is generally grounded on honesty and transparency. There should be no fear to confront and tell each other off if we are truthful to the principles of Pan-Africanism.

Education: Key to empowerment of women

DUCATION is the key to development and empowerment and must be provided to all. However, this is not always the case for women and girls.

I was puzzled to find out that a young lady who came to help with some chores at my house had a very limited education, while her brothers were university graduates. Of course, this was not the first time I have met girls and women, who were deprived of education because their families believe that they will one day get married, and that there is no need to invest a great deal in their education. This is, unfortunately, a commonly-believed and practiced gender discrimination, which affects millions of girls and women all over the world.

Education is a basic human right and must be provided for all — girls and boys, women and men. The Universal House of Justice, the governing council of the Bahá'í international community, states that "The cause of universal education ... deserves the utmost support that the governments of the world can lend it. For ignorance is indisputably the principal reason for the decline and fall of peoples and the perpetuation of prejudice. No nation can achieve success unless education is accorded all its citizens".

Education and training of every child, their personality, talents, mental and physical abilities and spiritual qualities to their fullest potential, is the right of every child. Education of girls is not only a fundamental human right. It is also in the best interests of society as a whole.

The Bahá'í Writings state: "... men and women are equal in the sight of God ... there is no distinction to be made between them. The only difference between them now is due to lack of education and training. If woman is given equal opportunity of education, distinction and estimate of inferiority will disappear".

Mother is the first educator of the child. In a family, for example, although both parents should share in the overall responsibility of educating their children, but mother is given recognition as their first educator. The spiritual, emotional and intellectual education of women and girls is, therefore, necessary because a mother cannot pass on what she does not have.

Furthermore, education and empowerment of women is crucial for the development and advancement of society. Without the qualities, talents and skills of both women and men, full social and economic development of the planet is impossible.

The benefits of woman's education is not only in terms of social economic development, as people often view it. But material well-being is one of the many benefits our communities derive from women's and girls' education.

The full participation of everyone, including women, is required for the well-being and advancement of our communities. For this to happen, girls, as well as boys, must be valued by their families and by society and given



equal opportunities in all fields of human endeayour.

The Bahá'í Writings state: "Until the reality of equality between man and woman is fully established and attained, the highest social development of mankind is not possible" and that "The world of humanity is possessed of two wings: the male and the female. So long as these two wings are not equivalent in strength, the bird will not fly. Until womankind reaches the same degree as man, until she enjoys the same arena of activity, extraordinary attainment for humanity will not be realized; humanity cannot wing its way to heights of real attainment".

Research concerning women's status and gender relations clearly shows the cost to society of the underdevelopment of women. Societies which oppress women have poorer economic, health and social indicators.

Empowerment of women contributes to peace

Women plays a central role in the development of families, communities and nations. As mothers, they bear the anxieties and difficulties of rearing children.

Having brought them to the age of maturity, they do not want to sacrifice their children in the battlefields.

Participation of women in all spheres of life is essential to social and economic development of the planet, the abolition of war, and the ultimate establishment of a united world.

According to the Bahá'í Writings: "when women participate fully and equally in the affairs of the world ... war will cease" and "The emancipation of women, the achievement of full equality between the sexes, is one of the most important, though less acknowledged pre-requisites of peace. ... Only as women are welcomed into full partnership {with men} in all fields of human endeavour will the moral and psychological climate be created in which international peace can emerge".

Equality between men and women is not easily attained. It requires education and patience with oneself and others, an unshakable determination, as well as moral and spiritual principles, which facilitate the shift in values and attitudes, required to achieve equality.

APAN has donated M31 million to boost Lesotho's school feeding programme. The East Asian country also donated 230 tonnes of tinned fish and 510 tonnes of fortified foods through the World Food Programme (WFP).

Speaking during a recent handover ceremony in Maseru, Foreign Affairs Minister, Matšepo Ramakoae, said about 52 000 learners would benefit under the feeding scheme.

Ms Ramakoae said Japan's contribution

would boost efforts to address malnutrition, undernutrition, stunting and low enrolment rates at pre-primary and primary levels.

"We hope to see improved school attendance and increased access to food. Some children attend school because it is the only place they can access a decent meal," she said. The donation would also contribute positively to shaping Lesotho's socio-economic development. Ms Ramakoae commended the WFP for ensuring that donated food reached the intended targets. Japanese Ambassador to Lesotho, South Africa and eSwatini, Maruy-

ama Norio, said they had decided to help the country to cushion it from food insecurity.

Ambassador Norio said Lesotho's food security situation was deteriorating due to high commodity prices and the adverse effects of the Covid-19 pandemic.

"This aid is aimed at improving food security and supporting Lesotho's economic and social development. We are delighted to contribute towards improving the livelihood of vulnerable people," he said.

For her part, WFP Country Director, Aurore Rusiga, said Japan's support came at a

critical time when the world is facing a severe food crisis.

According to the Lesotho Vulnerability Assessment Committee, about 521 000 people are food insure and need humanitarian support

"This contribution by Japan will be used to reduce food insecurity in the country. We will ensure continuous and undisrupted provision of school meals by providing fortified maize meal and canned fish to pre-primary and early childhood care and development centres nationwide," Ms Rusiga said.

IGERIAN Afrobeats star Burna Boy burst onto the global stage in 2018 with a slew of irresistible hits on his third album, Outside, accompanied by mandatory fiendish good looks and charm. Grammy and BET awards helped firm up his status within a highly competitive global music industry.

Before his international success, which has been cemented by his latest offering Love, Damini (2022), Burna spent years experimenting with different sounds in London and South Africa and his ragga-inspired vocal style became distinctive.

His 2014 contribution to South African hip hop mainstay AKA's infectious song All Eyes on Me first put him on the African radar. His smouldering hook on the multiple award-winning track made all the difference and demonstrated he was an artist to watch, channelling both West African and Jamaican musical flavours.

Although he was deemed talented by his South African hip hop peers, his shine remained somewhat muted. He had to return to his native Nigeria to attain the level of success he obviously yearned: awards, global tours and A-class industry connections.

Although he rose in a whirlwind, with an enigmatic combination of singing styles and

influences, Burna Boy has, at least for the moment, become mainstream; a slightly compliant agent of the commercial music industry. (The same is true of most of today's Afrobeats stars, even if this is a Faustian truth everyone might choose to ignore.)

On Love, Damini (he was born Damini Ebunoluwa Ogulu) Burna still exudes just the right amount of foreboding and palpable intrigue to remain credible as an artist. But how much of his much-touted originality does he have left? Perhaps a way to begin to answer this question is to revisit his musical influences.

Spotting his influences

It is difficult not to love club bangers such as Soke, Ye, Gbona and On the Low, all produced before Burna Boy's groundbreaking 2021 Grammy win with his fifth album, Twice as Tall (2020).

In most of these songs, Fela Kuti's influence is crystal clear in samples and the unequivocal lifting of various hooks. For many, it seemed like Burna was Kuti's heir apparent.

From the late 1960s Nigerian musician and singer Kuti, along with his amazing bands, almost single-handedly pioneered a genre called Afrobeat. This sound incorporated strong Pan Africanist politics, intricate call and response singing, and heavy West African drumming laced with enticing jazz and funk riffs. Afrobeats is an umbrella term for a more radio-friendly and commercial version of Kuti's Afrobeat.

Burna Boy's Kuti credentials appear impeccable. His maternal grandfather, the broadcaster and jazz enthusiast Benson Idonije, had managed Kuti in the 1960s. His mother and manager, business woman Bose Ogulu, had danced in Kuti's troupe.

Burna has also been influenced by ragga, dub and grime ever since his days as a student in the UK. The foundations of these genres were laid mainly in Jamaica but found fresh creative wings in urban UK music scenes. This culminated in a hit like Burna's 2017 song Rock your Body.

Even before the arrival of Love, Damini, Burna Boy had succeeded in melding his diverse cultural and sonic experiences into one powerful aural stew.

Burna has not only cribbed the Jamaican sound. He's also adopted the rude boy persona with tales of private security gunshots, rape allegations and a trail of broken hearts that have clouded his already threatening aura.

Ways to weigh Burna

Obviously, Burna was aiming to act as some kind of generational spokesperson for a restless and burgeoning Afropolitan brigade. It couldn't have been otherwise after being fed on a diet of Kuti-inspired Pan Africanism and neocolonial resistance. By most standards, this is heavy stuff for a market and generation captured by instant gratification.

And then he struck musical gold with his eclectic brew of West African

rhythms, West Indian jungle grooves and the ubiquity of hip hop. Burna once described part of this gumbo as "pepperoni pizza" with Kuti's Afrobeat as the dough. There is nothing particularly unique about this recipe. Instead, the X factor can be found in his own winning combination of ingredients – bound with an arresting personality. Of course, there's also his amazing dexterity in sampling to ponder.

He has proclaimed that his brand of music is a new genre called Afrofusion. Probably this is just a way of leveraging newfound success for greater effect. A way to distinguish himself from the teeming throng of Afrobeats aspirers.

To the undiscerning, Burna Boy's sound is pure genius. But for those conversant with Kuti, with Jamaican godfather of dub, Lee "Scratch" Perry, and similar genres of Caribbean toasting (lyrical chanting over dancehall music), it all seems a bit déjà vu.

There are different ways to weigh Burna. If we put him against Kuti, Perry and the greats of dub, he is arguably minor. But in an incessantly Instagrammed era, endlessly photographed and reproduced, he is a giant bristling with substance, creative menace and yet to be decoded

times, it isn't even certain that Burna recognises the depth of what he is channelling. If he did, he wouldn't be so eager to pair up with every hot music star that pops up on the scene.



Burna's lyrics in hits such as Last Last (2022) are replete with profanity, inanity and nonsense rhymes that sound good to the ears especially if you happen not to understand West African pidgin. This is yet another aspect of his work that can be quite bewildering; the sudden swings between sense and nonsense, pseudo-philosophical gravity and outright puerility.

Rolling in dollars

Lately, Burna has launched a campaign to gain even greater success. Just look at his high profile collaborations with the likes of US musicians Pop Smoke and Beyoncé as well as UK pop stars like Sam Smith, Ed Sheeran and Stormzy or Nigerian singer Wizkid.

Already, some of his hits are beginning to sound a little laboured, over-thought or under-thought. But perhaps this hardly matters as long as the dollars, brand endorsements and festival invitations keep rolling in. In today's music industry, that's all that counts.

Pelosi's visit to Taiwan is a serious provocation

N August 2, Speaker of the US House of Representative Nancy Pelosi made a provocative visit to China's Taiwan region in disregard of China's strong opposition and serious representations. The visit is a serious violation of the one-China principle and the provisions in the three China-US joint com muniqués. It has a severe impact on the political foundation of China-US relations, and seriously infringes on China's sovereignty and territorial integrity. It gravely undermines peace and stability across the Taiwan Strait, and sends a very wrong signal to the separatist forces for "Taiwan independence".

Taiwan has been an inalienable part of China's territory since ancient times. There are plenty of historical records and documents that show how the Chinese people developed Taiwan in earlier periods. The world's earliest account of Taiwan could be

Since 1335, the Chinese central government has exercised effective jurisdiction over Taiwan. "Taiwan" was first used in official documents in the Ming dynasty, and has become the established name ever since. In April 1895, Japan forced the defeated Qing government to cede Taiwan and the Penghu Islands.

On 1st December 1943, the Cairo Declaration released by China, the US and the UK stated that it is the purpose of the three countries that all the territories Japan had stolen from Chinese, such as Taiwan and Penghu shall be restored to China.

The Potsdam Proclamation signed by China, the US and the UK on 26 July 1945 reiterated that "the terms of the Cairo Declaration shall be carried out". On 15th August 1945, Japan surrendered unconditionally. Taiwan was recovered on 25th October of the same year.

Since then, Taiwan and Penghu have been put back under China's sovereign jurisdiction and recognized as a part of China legally and politically as well as in reality.

As a result of the Chinese civil war from 1945 to 1949, the defeated Nationalists retreated to Taiwan, set up a regime on the island, and created a special situation of prolonged political antagonism between the two sides across the Taiwan Strait, from which the Taiwan question arose.

However, China's sovereignty and the territorial integrity have never been divided, and the fact that the two sides of the Strait belong to one and the same China and that Taiwan is part of China has never

United Nations General Assembly Resolution 2758 adopted in 1971 made it clear that there is but one China in the world, Taiwan is an inalienable part of China's territory, and the Government of the Peoples' Republic of China is the sole legal government representing the whole of China.

The Resolution "restore all its rights to unofficial relations the People's Republic of China and to recog- with the people of nize the representatives of its Government as the only legitimate representatives of China to the United Nations, and to expel as part of the US forthwith the representatives of Chiang Government, Kai-shek from the place which they unlawfully occupy at the United Nations and in all the organizations related to it."

The one-China principle has already become the prevailing consensus of the international community and a widely-accepted basic norm in international relations.

As many as 181 countries, including the in the US presidential line of succession. US, has established diplomatic relations with China on the basis of the one-China principle.

The US side has made solemn commitments to China on the one-China principle and in the three China-US joint communi-

The one-China principle is the center-

qués, and the premise and foundation for the establishment and development of diplomatic relations between China and the US.

In 1979, the US made a clear commitment in the Sino-US Joint Communiqués on the Establishment of Diplomatic Relations that "the United States of America recognizes the Government of the People's Republic of China as the sole legal Government of China" and "within this context, the people of the United States will maintain cultural, commercial and other

Taiwan".

The US Congress, obliged to strictly follow the one-China policy of the US

Government and not engage in any official interactions with China's Taiwan region. Pelosi is the incumbent Speaker of the US House of Representatives, and ranks second

Therefore, it is only natural that China makes firm responses, including military exercises, which are consistent with domestic and international law and practice.



Margaret Howe Lovett and her sexual encounters with a dolphin



MARGARET Howe Lovatt and a dolphin.

HEN a young Carl Sagan visited St. Thomas' Dolphin Point laboratory in 1964, he likely didn't realize how controversial the setting would

Sagan belonged to a secretive group called "The Order of the Dolphin" which, despite its name, focused on searching for extra-terrestrial intelli-

Also, in the group was the eccentric neuroscientist Dr. John Lilly. His 1961 quasi-sci-fi book Man and Dolphin highlighted the theory that dolphins wanted to (and likely could) communicate with humans. Lilly's writings sparked a scientific interest of the sparked as tific interest in interspecies communication that set-in motion an experiment that went a bit... awry.

Trying to connect dolphins and humans Astronomer Frank Drake headed the National Radio Astronomy Observatory's Green Bank Telescope in West Virginia. He'd spearheaded Project Ozma, the search for extraterrestrial life through radio waves emitted from other planets.

Upon reading Lilly's book, Drake excitedly drew parallels between his own work and Lilly's. Drake helped the doctor secure funding from NASA and other government entities in order to realize his vision: a communicative bridge between human and dolphin.

Lilly then built a laboratory housing a workspace on the upper level and a dolphin enclosure on the bottom. Tucked away on the picturesque shore of the Caribbean, he called the alabaster building Dolphin Point.

Ŵhen 23-year-old local Margaret Howe Lovatt realized that the lab existed, she drove there out of sheer curiosity. She fondly remembered stories from her youth where talking animals were some of her favorite characters. She'd hoped to somehow witness the breakthrough that

Arriving at the lab, Lovatt encountered its director, Gregory Bateson, a famous anthropologist in his own right. When Bateson inquired as to Lovatt's presence, she replied, "Well, I heard you had dolphins ... and I thought I'd come and see if there was anything I could do."

Bateson allowed Lovatt to watch the dolphins. Perhaps wanting to make her feel useful, he asked her to take notes while observing them. Both he and Lilly realized her intuitiveness, despite any lack of training and offered her an open invitation to the lab.

Margaret Howe Lovatt Becomes A Diligent Researcher

Soon Margaret Howe Lovatt's dedication to Lilly's project intensified. She worked diligently with the dolphins, named Pamela, Sissy, and Peter. Through



daily lessons, she encouraged them to create human-esque sounds.

But the process was becoming tedious with little indication of progress

Margaret Howe Lovatt hated leaving in the evenings and still feeling that there was much work left to do. So she convinced Lilly to let her live in the lab, waterproofing the upper rooms and flooding them with a couple feet of water. This way, human and dolphin could occupy the same space.

Lovatt chose Peter for the revamped, immersive language experiment. They co-existed in the lab six days of the week, and on the seventh day, Peter spent time in the enclosure with Pamela and Sissy.

Through all Peter's speech lessons and voice training, Lovatt learned that "when we had nothing to do was when we did the most ... he was very, very interested in my anatomy. If I was sitting here and my legs were in the water, he would come up and look at the back of my knee for a long time. He wanted to know how that thing worked and I was so charmed by it.

Charmed might not be the word to describe how Lovatt felt when Peter, an adolescent dolphin with certain urges, became a bit more... excited. She told interviewers that he "would rub himself on my knee, my foot or my hand." Moving Peter oack down to the enclosure each time this happened became a logistical nightmare.

So, reluctantly, Margaret Howe Lovatt decided to satisfy the sexual urges of the dolphin manually. "It was just easier to incorporate that and let it happen ... it would just become part of what was going on, like an itch, just get rid of that scratch and we would be done and move on."

Lovatt insists "it wasn't sexual on my part ... sensuous perhaps. It seemed to me that it made the bond closer. Not because of the sexual activity, but because of the lack of having to keep breaking. And that's really all it was. I was there to get to know Peter. That was part of Peter.'

Meanwhile, Drake's curiosity about Lilly's progress grew. He sent one of his colleagues, the 30-year-old Sagan, to check the goings-on at Dolphin Point.

Drake was disappointed to learn that

the nature of the experiment was not as he'd hoped; he'd expected progress in deciphering the dolphin language. This was likely the beginning of the end for Lilly and his crew's funding. Nevertheless, Lovatt's attachment to Peter grew, even as the project waned.

But by 1966, Lilly was more enthralled with the mind-altering power of LSD than he was with dolphins. Lilly was introduced to the drug at a Hollywood party by the wife of Ivan Tors, the producer of the movie Flipper. "I saw John go from a scientist with a white coat to a full-blown hippy," Lillie's friend Ric O'Barry recalled.

Lilly belonged to an exclusive group of scientists licensed by the government to research the effects of LSD. He dosed both himself and the dolphins at the lab. (Though not Peter, at Lovatt's insistence.) Luckily the drug seemed to have little to no effect on the dolphins. However, Lilly's new cavalier attitude towards the animal's safety alienated Bateson and put a stop to the lab's funding.

Thus, Margaret Howe Lovatt's live-in experience with a dolphin ended. "That relationship of having to be together sort of turned into really enjoying being together, and wanting to be together, and missing him when he wasn't there," she reflects. Lovatt balked at Peter's departure to Lilly's cramped Miami lab with lit-

A few weeks later, some terrible news: "John called me himself to tell me" Lovatt notes. "He said Peter had committed sui-

Ric O'Barry of the Dolphin Project and Lilly's friend validates the use of the term suicide. "Dolphins are not automatic airbreathers like we are ... Every breath is a conscious effort. If life becomes too unbearable, the dolphins just take a breath and they sink to the bottom."

A heartbroken Peter didn't understand the separation. The sorrow of losing the relationship was too much. Margaret Howe Lovatt was saddened but ultimately relieved that Peter didn't need to endure life at the confined Miami lab. "He wasn't going to be unhappy, he was just gone. And that was OK."

Lovatt remained in St. Thomas after the failed experiment. She married the original photographer that worked on the project. Together, they had three daughters and converted the abandoned Dolphin Point laboratory into a home for their family.

Margaret Howe Lovatt didn't speak publicly of the experiment for nearly 50 years. Recently, however she granted interviews to Christopher Riley for his documentary on the project, the aptly named The Girl Who Talked to Dolphins.

AIROBI, Kenya — Africa's public health agency says the continent of 1.3 billion people still does not have a single dose of the monkeypox vaccine, but "very advanced discussions" are underway with at least two partners.

The acting director of the Africa Centers

Africa CDC in 'advanced' talks to obtain monkeypox vaccines

for Disease Control and Prevention, Ahmed Ogwell, told journalists on Thursday that he could not give details, but he said the partners are "largely multilateral institutions and non-African governments." There are no discussions with the private sector because all available doses have already been bought by countries, he said.

But a clinical trial is underway in Congo

for a vaccine, Jynneos, that's under emergency use authorization, Ogwell said. The two-dose vaccine is considered the main medical weapon against the disease, but its availability is limited. The Africa CDC did not immediately respond to a question about details of the trial.

More monkeypox deaths have been reported on the African continent this year than anywhere in the world. Since May, nearly 90 coun-

tries have reported more than 31,000 cases.

At least 2,947 monkeypox cases have been reported in 11 African countries this year, including 104 deaths, but most of the cases reported are suspect ones because the African continent also lacks enough diagnostic resources for thorough testing, the Africa CDC director said.

The lack of vaccine doses and shortage of diagnostics is an echo of the challenges that Africa's 54 countries faced for months during the COVID-19 pandemic as richer countries elsewhere raced to secure supplies.

The Africa director spoke as U.S. Secretary of State Antony Blinken is on the final leg of a three-country Africa visit, where he articulated Washington's new strategy for engaging with sub-Saharan African nations as "equal partners." Earlier this week Blinken was in Congo, which has many of the 136 new monkeypox cases reported across Africa in the past week.

The World Health Organization classified the escalating outbreak of the once-rare monkeypox disease as an international emergency in July; the U.S. declared it a national emergency last week.

Outside of Africa, 98% of cases are in men who have sex with men. With a limited global supply of vaccines, authorities are racing to stop monkeypox before it becomes entrenched.

Monkeypox spread typically requires skin-to-skin or skin-to-mouth contact with an infected patient's lesions. People can also be infected through contact with the clothing or bedsheets of someone who has monkeypox lesions.

Most people infected with monkeypox recover without treatment, but it can cause more severe symptoms like brain inflammation and in rare cases, death. The version of monkeypox spreading in Europe and North America has a lower fatality rate than the one circulating in Africa, where people have mostly been sickened after contact with infected wild animals like rodents and squirrels.

Long-awaited goal of ensuring every child is born HIV-free

CIENCE has gifted us tools and evidence-based approaches to ensure that there is minimal risk of transmission of HIV virus from HIV-positive parents to the child during pregnancy, de-livery and breastfeeding. Despite these tools existing since almost two decades now to ensure every child is born HIV-free to positive parents, we have failed to implement them fully. As per UNAIDS, despite substantial progress made in the last two decades to ensure that every child born to positive parents is HIV-free, 150,000 children were born with HIV in 2020. This is nearly eight times more than the desired "goal of achieving less than 20,000 children born with HIV worldwide by 2020". More worrying is that the pace of the decline has slowed in recent years.

Dr Glory Alexander, who has been devotedly working for providing medical care to people living with HIV, for more than three decades, spoke with CNS (Citizen News Service) spoke around the 24th International AIDS Conference (AIDS 2022).

Besides, being one of the organisers of this world's largest AIDS conference taking place in Montreal, she is also the founder of ASHA Foundation (Action, Service, and Hope for AIDS Foundation) in Bengaluru, India, and elected as national Vice President of AIDS Society of India.

According to the latest report of NACO (National AIDS Control Organization of India), in 2020-21 a little more than half (56 percent or 11,744) of the estimated HIV

positive pregnant women (20,900) received care through HIV counselling and testing services in government and private healthcare facilities. Of those diagnosed HIV positive, 10,937 pregnant women were initiated on or were already on lifelong antiretroviral therapy and 85 percent infants born to HIV-positive mothers were put on antiretroviral prophylaxis. The report further says that 'To achieve the target of elimination of Motherto-child transmission of HIV, there is a need of significant improvement since overall coverage of Prevention of Mother to Child Transmission (PPTCT) cascade service is low at National level as well as inter-State level.'

Dr Alexander said that, "In India women constitute about 44 percent of those infected with HIV. Women who come from HIV key affected populations such as sex workers, are more likely to be reached by HIV services periodically and receive care. But 90 percent of the women living with HIV in India are housewives who mostly get infected through their husbands. When they get pregnant, HIV infection could get transmitted to their children.

It is very important to target these women, more so as they do not perceive themselves to be at risk of HIV infection as they are likely to have single partners and may not be indulging in risky sexual behaviours. Moreover, Indian women are perceived as caregivers but themselves have poor health-seeking behaviour. So, they rarely come by themselves to get tested,

even though it is very important to diagnose these women early on."

However, women are likely to reach out to a health facility during pregnancy. "That is a good time to do their HIV test and put them on treatment, if diagnosed HIV positive. The treatment also prevents the risk of transmission to the child during the mother's pregnancy.

Treatment for prevention of mother to child transmission brings down the risk of transmission from about 40 percent in the breastfeeding population to less than 5 percent. If a woman is already on antiretroviral therapy and she becomes pregnant the risk of transmission is less than 1 percent," shared Dr Alexander.

"Women are more prone to comorbidities like cardiovascular and cerebrovascular diseases. They also respond in a different manner to antiretroviral therapy as we have to worry about their bone health and there is an increased risk of cancer of the cervix in women who are HIV positive. Thus, women and children are very important cogs in the wheel for the management of HIV infection and need to be diagnosed and treated early on", she added.

In India every year 27 million women get pregnant and hidden among them are about 20500 women who are HIV-positive. "It is very difficult to be able to trace all these 27 million women and test them for HIV. So one barrier is testing such a large pool of pregnant women every year.

As per the annual 2020-21 report of NACO, till September 2020 they

were able to test about 15.7 million women for HIV and of these about 9, 000 were found to be HIV positive. Another problem is that even today many women in the rural areas do not come to a hospital even for an antenatal check-up, though that is slowly improving over the years," said Dr Alexander.

Not a single HIV positive child born to positive parents in Dr Glory's cohort

"Today in India many HIV positive women want to have children and in the past few years I have not had a single positive child born in my small cohort of pregnant women as I test them all and put them on antiretroviral therapy if found positive. To have or not have a child is a woman's individual or personal decision or choice and should not be forced on her. We still have instances in India where many HIV positive women were being falsely advised to have an abortion as they were told their child would be born HIV positive. In fact, if an HIV positive woman wants to become pregnant we must support and help her so that she gives birth to an HIV negative infant," said Dr Glory Alexander.

Thirty-five years of medical service of people living with HIV: how did it begin?

"In 1987, I had just started working as a Consultant physician at Baptist Hospital in Bengaluru, capital of India's state of Karnataka. One Monday morning while doing my hospital ward rounds, I came across a newly admitted American patient who was very sick with a respiratory problem. He asked me

if he had AIDS. I was shocked, because at that time even we doctors had very little knowledge about AIDS. After sending him to the intensive care unit, I went to the library to read up on AIDS and was convinced that he was suffering from Pneumocystis pneumonia, a very common opportunistic infection in people who are infected with HIV.

I sent his blood sample for diagnosis to my alma mater Christian Medical College Vellore, as no HIV testing facilities were available in Karnataka at that time. We lost the patient 36 hours after my first interaction with him. His test results came one week later confirming that he was HIV positive. He died a lonely painful death far away from his family.

I learnt later that he was a homosexual person from San Francisco who had come to India because of the stigma he was facing in his own country. His death impacted me severely. I wanted to do something for the people living with HIV. I finally resigned from my full-time hospital job and started ASHA Foundation to contribute my two bits for society.

We started an AIDS helpline to keep people informed about HIV and also a clinic for HIV-positive patients. Later we included adolescent health education, camp rainbow for HIV positive children, care and support services for families and people infected with HIV and prevention of mother-to-child transmission, as part of our services," shared Dr Alexander.

RETORIA — US Secretary of State Antony Blinken said US President Joe Biden was looking forward to hosting President Cyril Ramaphosa in Washington next month as the two nations seek to elevate their economic and trade ties.

Blinken is in Pretoria, hosted by International Relations and Co-operation Minister Naledi Pandor, for the South Africa-US Stra-

"Even with Covid-19, trade and investment between South Africa and the United States reached a record \$21 billion last year. But we know that we can make something good even better. As South Africa's second largest trade partner we are committed to continue with this robust, dynamic and mutually beneficial partnership," Blinken told journalists in Pre-

"Today was not the culmination of our partnership but I think the start of a new chapter. President Biden is very looking forward to welcoming President Ramaphosa to Washington next month. And in December we are incredibly excited to be hosting the US-Africa Leaders Summit, picking up something President Obama started, and we welcome South Africa's input in making that summit a suc-

Welcoming Blinken to "beautiful" South Africa, Pandor said the visit had been discussed several times. Pandor also welcomed US Ambassador-designate Reuben Brigety as he starts his tenure in Pretoria.

"I am glad that you are able to observe this meeting and visit. I hope our deliberations today will set the tone for your tenure in South Africa. I wish you a productive and enjoyable term as USA ambassador to South Africa. I hope you will contribute to strengthening the already strong links between South Africa and the USA," said Pandor.

She said the US was one of South Africa's most valued partners.

"I appreciate the commitment you have shown to expanding our bilateral relations. The bonds that were forged between the United States and South Africa during the struggle for democracy and racial justice in this country are enduring and created a firm foundation for advancing people-to-people co-operation between the two countries, including in the spheres of education, cultural and tourism exchanges," said Pandor.

Pandor said recently that the government was thankful for the "tremendous support" shown by US companies for Ramaphosa's investment drive. "The Zimbabwe Exemption Permit will expire at the end of this year. Its expiry is naturally causing much anxiety to the holders of this permit," Shava said in his opening remarks while co-chairing the midterm review of the Bi-National Commission (BNC) with International Relations and Cooperation Minister Naledi Pandor.

"Our two governments must work closely in the implementation of this decision. We are ready to receive our nationals back home," he

Among several senior officials from the two nations, the high-level meeting was also attended by Ambassador of South Africa to Zimbabwe, Thizwilondi Rejoice Mabudafhasi, and Ambassador of Zimbabwe to South Africa, David Hamadziripi.

Numerous Zimbabweans living in South Africa are in limbo, after the South African government announced that it would not be ex-

Pandor also expressed gratitude to Zimbabwe for the support given to South Africa when it served on the SADC Organ on Politics, Defence and Security Cooperation.

Shava, a seasoned diplomat, was appointed by Mnangagwa to head the Ministry of Foreign Affairs last year, following the death of the country's Foreign Affairs Minister Sibusiso Moyo. — IOL

Blinken rebukes Rwanda over rights, suppression concerns

IGALI, Rwanda — U.S. Secretary of State Antony Blinken on Thursday rebuked Rwandan authorities over democracy and human rights concerns, saying the central African country may not reach its full potential without opening up political space and protecting freedoms.

"We recognize Rwanda's incredibly difficult history of the 1994 genocide and we know the ongoing legacy of that genocide but the criminalization of some people ... in politics, harassment of those who express opposition views to the current government, we believe (that) undermines total peace and stability and success which has been extraordinary in the case of Rwanda," said Blinken at a press briefing. He was speaking in the Rwandan capital of Kigali, the last stop on his three-nation tour of Africa.

Earlier Blinken toured a memorial for victims of Rwanda's 1994 genocide, saying he was "moved by this memorial and inspired by the resilience of the survivors and the remarkable progress of this coun-

Blinken laid a wreath at the mass graves honouring the more than 800,000 victims of the genocide perpetrated by Hutu extremists against the Tutsi ethnic group and moder-

"My family experienced the horrors of holocaust and I appreciate the importance of memorializing such tragic events," Blinken wrote in a guest book at the memorial. "The United States strongly supports Rwanda's continued efforts towards renewal and national reconciliation.

One of Blinken's aims in Rwanda is to engage officials regarding the case of Paul Rusesabagina, a U.S. permanent resident whose convic-

tion on terror charges and incarceration has drawn attention to what some say is the Rwandan government's harsh treatment of its critics at home and abroad.

Rusesabagina is the hero of the Hollywood film "Hotel Rwanda," which dramatized his efforts as a hotel manager to shelter hundreds of Tutsis during the genocide. The U.S. asserts that Rusesabagina, a recipient of the U.S. Presidential Medal of Freedom, is wrongfully jailed in Rwanda.

"We have been clear about our position with the trial of Paul Rusesabagina. We still have conviction that the trial wasn't fair," Blinken

"I discussed this with President Paul Kagame but I won't go into specifics of our discussion, but will continue to engage and also follow up with the family."

Many activists believe only diplomatic intervention from Washington can possibly help Rusesabagina, 68, who has suffered poor health in recent years, according to

He was sentenced to 25 years last September. His conviction came more than a year after he disappeared during a visit to Dubai in the United Arab Emirates and appeared days later in Rwanda in handcuffs, accused of supporting the armed wing of his opposition

Blinken, who visited South Africa and also went to Congo earlier in the week, comes to Rwanda at a particularly difficult time for Africa's Great Lakes region, with the small central African nation at odds with vast neighbour Congo over allegations that both governments support rebels opposed to

Blinken said he told Kagame that the recent U.N. report accusing Rwanda of supporting the M23 re-

Rwandan authorities deny those charges and have rejected the report by U.N. experts as a move "to distract from real issues."

Rwandan authorities in turn accuse Congo of giving refuge to ethnic Hutu fighters who played roles in Rwanda's 1994 genocide that killed ethnic Tutsis and moderate

There have long been tensions between the countries. In the late 1990s, Rwanda twice sent its forces deep into Congo, joining forces with rebel leader Laurent Kabila to depose the country's longtime dictator Mobutu Sese Seko.

After his meetings with the leaders of Rwanda and Congo this week, Blinken said he believes both are committed to peace talks and he said the U.S. will support Africanled efforts to end the fighting.

"My message to both presidents of Congo and Rwanda this week has been the same. Any support of any armed group in eastern (Congo) endangers local communities and regional stability and every country in the region must respect the territorial integrity of the others," he

A meeting between Kagame and Tshisekedi in Angola on July 6 produced a statement calling for a return to normal diplomatic relations, a cessation of hostilities and the "immediate and unconditional withdrawal" of the M23 from its positions in eastern Congo.

But M23, which comprises mostly ethnic Tutsis from Congo, continues to hold its positions near the border with Uganda, keeping the spotlight on Rwanda.

The chairman of the U.S. Senate Foreign Relations Committee in a letter to Blinken last month called for a comprehensive review of U.S. policy toward Rwanda and noted his concern that Washington's support for Rwanda, widely described by human rights groups as authoritarian and repressive, is not in line with U.S. values.

WANDA and the Democratic Republic of Congo (DRC) make for very unĥappy neighbours. Both sides claim the other is set on bringing down their government, and violating past agreements and interna-

Rwanda accuses the DRC of working with the Forces Démocratiques de Libération du Rwanda (Democratic Forces for the Liberation of Rwanda) or FDLR. The rebel group's stated aim is to overthrow the Rwandan gov-

For its part, the DRC accuses Rwanda of violating its sovereignty by supporting the Mouvement du 23 Mars (March 23 Movement, M23). The rebel group, along with multiple others, is active in the DRC.

A recent United Nations report supports Kinshasa's contention. The group of experts on the Democratic Republic of Congo detailed its accusations in a 131-page report. Kigali, however, dismissed the findings as "false al-

and occupies 26,000 square kilometres. DRC, on the other hand, has 90 million people and covers a territory of 2.3 million square kilometres. The DRC lies to the west of Rwanda. The two countries share a border of about 217 kilometres.

Tensions between the two nations date back to the 1994 genocide in Rwanda when an estimated one million Tutsis and moderate Hutus were killed. Many of the perpetrators of the violence fled to the DRC, at the time called Zaire. The post-genocide Rwandan government launched military operations in a bid to force the perpetrators back home to face justice.

Rwanda believes the DRC continues to provide refuge for those behind the 1994 attack.

The two countries have gone through two major wars and multiple skirmishes. They have also had periods of stability and trade growth. The latest tensions, however, are cause for concern. They risk destabilising the

Rwanda and DRC's turbulent past continues to fuel their torrid relationship

Eastern Africa region, disrupting trade routes and allowing for the establishment of opportunistic militia groups.

The issue is on US Secretary of State Antony Blinken's agenda as he tours three African nations in August 2022. He will meet with Congolese and Rwandan leaders to negotiate for peaceful resolution to the current conflict.

But, based on a decade of research into relations between the two countries, I do not believe Blinken's visit will to lead to any significant reduction in tensions. The most recent events are not new. Both nations hold old suspicions of each other.

How it started

Rwanda is a country of 13 million people Since the 1994 genocide, the Rwandan government has kept a close eye on DRC. While 4 July is marked in Rwanda as the day the genocide ended, it was a temporary pause.

> After two years of inaction from the then Zaire president Mobutu Sese Seko, Rwanda went after those it believed were behind the attacks and were hiding in Zaire. It carried out military operations that triggered the First Congo War (1996-1997).

> This war had two objectives. The first was to disband the refugee camps that were hosting the remnants of the genocide perpetrators. An estimated two million refugees were forced back into Rwanda.

> The second objective was the removal of Mobutu on the grounds that he was providing a haven for genocide actors. The Zairian dictator was removed from power in May 1997.

Within nine months, the war was over. With Rwanda's support, Laurent Kabila and his Alliance des Forces Démocratiques pour la Libération du Congo-Zaïre (Alliance of Dem-

ocratic Forces for the Liberation of Congo, AFDL) took over power.

But a much bloodier Second Congo War (1998-2003) soon followed. This was catalysed by two events. First, the dismissal of the Congolese defence minister James Kabarebe, who was Rwandan and largely responsible for conducting the First Congo War.

Second, Congo's support for the remnant genocide forces, Armée pour la Libération du Rwanda (Army for the Liberation of Rwanda,

The Second Congo War dragged on for five years. It led to the deaths of millions of people. This was as a result of the actual fighting, and the increase in disease and malnutrition.

The lack of a quick resolution to the war resulted in various parts of the DRC being run by either militia groups, or the governments of neighbouring countries.

Even allies during the start of the war, such as Uganda and Rwanda, fought against each

Eventually, the 2002 Pretoria agreement led to the withdrawal of the Rwandan military from Congolese territory.

Nevertheless, Rwanda continues to contend that Congo supports genocide remnants, now operating as the FDLR.

For its part, DRC accuses Rwanda of supporting Congolese rebel groups, such as the Congrès National pour la Défense du People (National Congress for the Defence of the People, CNDP) and the M23.

Divisions in Kigali

The Rwandan government is divided on the

future of relations with its giant neighbour. One group of policy leaders perceives the DRC as a continual threat to Rwandan security. They view the Congolese military as being ineffective in combating forces stationed in the DRC that are expressly against the Rwandan government, such as the FDLR.

This group often dominates public policy decisions in Rwanda's foreign relations with

But there's a second group that focuses on the economic opportunities of closer Rwandan-Congolese relations.

They believe that Rwandan development should focus on the export of domestically produced goods to the Congolese market of 90 million potential customers.

Many within this group believe that the economic benefits outweigh the security concerns, which they argue have decreased in

Following the 2018 election, which saw Félix Tshisekedi become Congolese president, relations between Rwanda and the DRC improved. This included increased trade activity between the two nations.

It seemed for a while that the beliefs of Rwandans who wanted rapprochement with Kinshasa had the upper hand, hinting at a positive future for the two nations.

But in recent months, these hopes have been dashed. Once more, the dominant narratives involve allegations of DRC collaborating with the FDLR, and Rwanda with M23.

The two countries are likely to continue experiencing periods of stability and tension. Another major conflict, like the Congo wars, is unlikely, but the continual tensions prevent trade integration that would boost development and peace between the two nations.

US reaffirms pledge of indefinite military aid

Ukraine suggests smoking Russian soldiers caused Crimean blast

Ukraine's defence minister deflected questions about the massive fire at an air base in Crimea, suggesting it was caused by Russian soldiers smoking there.

"It's a dangerous place, they should not smoke there," Oleksiy Reznikov said in response to questions at a news conference in Copenhagen, declining to answer whether Ukrainians were involved in the incident.

A number of Ukrainian officials have posted memes or comments on social media about Russia's explanation of safety issues leading to the blast, including jokes about the dangers of smoking near explosives.

Ukraine wins bondholder approval to freeze debt payments

Ukraine won approval for a debt-payment

freeze from the holders of its international bonds, gaining some budget relief in the wake of Russia's invasion.

Investors representing around 75 percent of \$19.6-billion worth of Ukraine's foreign bonds agreed to defer coupon and principal payments until 2024, the Finance Ministry in Kyiv said on Wednesday.

Russian anti-war TV protester faces new probe

A Russian journalist who gained international attention when she staged a rare antiwar protest in March during a live broadcast on the country's main TV news channel said police had raided her Moscow apartment as part of a new probe against her.

Marina Ovsyannikova said officers also took her away for questioning in a criminal case under Russia's "fake news" law, over a protest she held near the Kremlin last month criticising President Vladimir Putin for civilian deaths in Ukraine.

"Are more than 350 children killed in Ukraine fakes?" Ovsyannikova wrote on Telegram. "How many more children have to die for you to stop?'

Russian oil flows resume to central Europe

Russia resumed oil flows towards Ukraine through a pipeline to central Europe after Hungary's sole refiner stepped in to resolve a problem over the payment of a transit fee.

The flows towards the southern leg of the Druzhba link were going as planned, Transneft spokesman Igor Dyomin told

Ukraine hopes to end 'active' war phase by end of August

The Ukrainian president's chief of staff says it is critical to finish the active phase of the war before cold weather sets in, Interfax reports.

The risk of Russian attacks on power and heat infrastructure remains, Andriy Yermak said in an interview with the news agency. Russia's army continues its attacks on infrastructure and Ukraine seeks to "take maximum steps to finish the active phase of the war by the end of August".

Inflation keeps climbing in Ukraine

Ukraine's inflation accelerated for a sixth consecutive month, fuelled in part by the central bank's decision to devalue the currency to shore up the nation's war-battered

Consumer prices surged by 22.2 percent in July from the previous year, compared with 21.5 percent in the previous month, official data published on Wednesday showed.

be signal to Putin

While Ukraine has remained silent on the cause of the explosions, Latvian Defence Minister Artis Pabriks predicted they would be a telling moment for Russia.

"I wouldn't say this is a turning point but I'd compare this to the first allied raids to bomb either Germany or to bomb Japan, by saying, look you cannot escape that fate which you are actually planning for others," he said in a brief interview on Wednesday. "We could see also yesterday those long queues of Russian cars that are trying to exit Crimea, so this is the right signal.'

Pabriks also said the blasts showed "capabilities are there", although it was unclear if he was basing his comments on direct knowledge of what caused them or the observations of defence analysts that it was probably a Ukraine attack.

Austin reiterates commitment to Ukraine

"We are committed to helping Ukraine, and providing them the equipment to defend their sovereign territory," Austin told reporters in Riga alongside Latvian Defence Minister Artis Pabriks.

The US military chief also reiterated Nato's commitment to maintaining a "persistent, rotational" presence in the Baltic region to protect the alliance's eastern flank.

Russia had committed a "significant portion" of its best military equipment to the invasion of Ukraine, and retained air and sea capabilities despite heavy losses, Austin said.

Hungary unblocks dispute over oil transit Hungary's biggest refiner said it paid Russia's transit fee to Ukraine to resolve a dispute that has led to a halt in oil flows to central Europe. Mol Nyrt, the oil company that sought to unblock supplies, said Ukraine and Russia both accepted its decision to step in.

Ukrtransnafta, which operates Ukraine's oil network, blocked the flow of Russian oil through Druzhba on August 4, Russian pipeline operator Transneft said on Tuesday.

The halt occurred after Transneft's payment of transit fees for August was rejected by European banks that wouldn't accept the cross-border transfer without approval from national regulators amid European sanc-

Denmark to train Ukrainian troops in UK Denmark will send 130 military instructors

to the UK, where they will train Ukrainian soldiers, according to the defence ministry in Copenhagen. The Nordic nation also plans to offer Ukrainians military training at facilities in Denmark, the ministry said.

Defence ministers from the UK, Ukraine and Denmark met on Wednesday in Copenhagen for a conference on military aid for the government in Kyiv.

Two more crop ships expected

at Ukraine ports
Two more vessels have been authorised to head to Ukrainian ports, pending inspections on Wednesday, according to a statement from the Joint Coordination Centre that oversees the grain corridor.

The Petrel S was expected to depart to Chornomorsk and the Brave Commander would go to Pivdennyi, while the Riva Wind, Glory and Star Helena — which are loaded with Ukrainian maize and sunflower meal had been inspected and were cleared to sail, the centre said.

Ukraine began shipping grain again this month, bringing some relief to squeezed global markets, but many challenges remain before the millions of tonnes of food stuck in the country can be released.

EU ban on Russian coal takes effect

A full European Union ban on imports of Russian coal kicked in on Wednesday following a four-month wind-down period. The provision of services needed to import coal, such as financing, brokering and technical assistance, is also banned.

The measure was approved by the bloc in April as part of a fifth package of sanctions. The EU said at the time that it would affect a quarter of all Russian coal exports, amounting to around an €8-billion loss of annual revenue. Restrictions on oil imports by sea begin to kick in later this year.

Biden signs Nato expansion measure

After signing the protocols for Finland and Sweden to join Nato, US President Joe Biden said the US and allies would "remain vigilant against any threats to our shared security" and "confront any aggression or threat of aggression that might come up".

He urged other Nato countries to finish their ratification process "as quickly as possible". Russia has denounced the move by the traditionally neutral Finland and Sweden as destabilising to the region.

US to help clear land mines

The US government is committing \$89-million to assist Ukraine in clearing land mines and other unexploded ordnance scattered through the country since Russia's invasion, a State Department official said.

The funds will go to nongovernmental organisations and entities to support the creation of 100 mine-removal teams to augment Ukraine's existing efforts, according to the official, who spoke on condition of anonymity in advance of a department announcement.

Steps to take when you are ready to restart your career

HERE are a lot of reasons to be out of the workforce. Maybe you took some time to raise your children or care for an ailing parent. Maybe you went back to school.

Maybe you grabbed a once-in-a-lifetime chance to travel the world. Whatever the reason, if you've been out of work for more than six months the prospect of returning can feel daunting. And if you've been out of the workforce for years, it can seem downright terrifying.

But, like most challenges, there's no way around it — you just have to go through it. These four concrete steps will help you on your journey and make you feel better prepared for your transition back into the workforce

Find an answer to "What do you want to do now?" For most people contemplating a career restart this is the most daunting part. I think that's for two reasons.

First, if you've been out of the workforce for a while you may not know what your options are and how well those options would fit you.

Second, and I think this is the bigger hurdle, you don't want to give an answer that will restrict your opportunities. I think the way to solve both of these problems is to focus on finding *an* answer but not *the* answer.

Consider what you did, what you know about what's out there and construct a "good enough" answer that also leaves open adjacent opportunities. As you get more information about the marketplace and how your skills compare, refine your answer.

Practice telling your story. Once you have identified your "good enough" answer to what you want to do, reach out to 3 to 5 friends or former colleagues who you trust to be kind, but also honest so that you can practice talking about what you want your next challenge to be.

Your answer needs to project confidence



that you have good ideas on how you can contribute while also conveying your openness to opportunities. The only way to be sure you are hitting the mark is to say it, out loud, to someone who will tell you the truth. You also need to practice answering the questions of how long you were out of the workforce and why.

Your goal is to be honest and not apologetic about your time out of the workforce. In your answer, be careful not to fall into TMI (too much information) territory. As you get better at telling your story, share it with a few people who are more likely to give you critical feedback so you can really hone your message.

Talk to as many people as possible. When you are restarting your career after time away what you lack most is information. And not the kind of information you can get on the internet. Information that you can only get by talking to people.

Who's hiring? What are they are hiring for? What will they be hiring for? And, most im-

portant of all, what are the skills and experiences that make someone the top candidate at that company?

Get current. Update your *LinkedIn* profile (and if you don't have one, get one!). Read news about your industry or the industry you are looking to join. Depending on how long your gap is and what your job was you may need to refresh your skills.

This can be done through online training or a more formal education program. You can also get current experience through pro bono work on behalf of nonprofits, freelancing or through a returnship.

And don't forget about your appearance. It's not that what you wear matters, but it does matter how what you are wearing makes you feel. But if it's been more than a few years since you last had to wear "work" clothes every day, investing in a few updated pieces will make you feel polished and pulled together.

WO Lesotho chess players have received International Chess Federation (FIDE) titles.

Sechaba Khalema and 'Malehloa Likhomo were awarded at the justended Chess Olympiad in Chennai,

The games ran from 28 July to 9 August 2022.

Lesotho finished a disappointing 129 out of 162 countries in the women's category and 164 out of 188 in the open section.

Despite the country's poor showing, Khalema was awarded a Candidate Master (CM) FIDE title for his outstanding performance.

Likhomo received a FIDE Women Candidate Master (WCM) title after she was voted Lesotho's best female

The country was represented by a team of 10 players.

The men's team had Klaas, Khalema, Tšephe Lebajoa, Bahlakoana Ntšonyana, and Bokang Motsamai.

The women's team was made up of WCM Maboloko Leboela, Likhomo, Nteboheleng Thetsane, Reitumetse Taioe, and Bonolo Ntsielo.

Speaking to Sunday Express, Likhomo said she was thrilled to get the title and this would motivate her to do even better in future.

"Getting a FIDE title means that I have to work harder to get higher rankings," she said.

Likhomo said she did not see the title coming after the team arrived late for the tournament due to visa delays. That saw the team missing some opening rounds.

"I was not expecting any title especially after we missed the opening rounds. However, I managed to get qualifying points from the games I played. Thus, I am happy."

This was Likhomo's second Olympiad after her debut in 2018 when the games were held in Georgia, United States.

As WCM, she is Lesotho's third woman with a chess title after Lieketseng Ngatane, who is a Women FIDE Master (WFM) and Maboloko Leboela who is also a WCM.

For his part, Khalema said he was delighted to finally get a title after participating at the world event since 2014 in Norway. He was also part of the Lesotho team in Azerbaijan in 2016 as well as Georgia in $\,$ from the games."



Group A has South Africa, Angola, Mauritius and Mozambique while Botswana, Malawi, Tanzania and Comoros are in Group C.


Meanwhile, Polotso Maapara and Nteboheleng Setoko have been appointed to officiate at the tournament.
